# MS 2529 Birmingham Shechita Board, 1826-1997

# **Administrative History**

The Birmingham Shechita Board and its predecessor, the Committee for Superintendence of Shechita, were responsible for supervising the butchers who supplied kosher meat to the Jewish community in Birmingham.

Records of the Board and the Committee date from 1891. Before this date, information about the supply of kosher meat can be found in the Council minutes of the Birmingham Hebrew Congregation (see JA/1/A). These show that Council oversaw the supply of kosher meat and that meat was taxed to raise money for the Congregation or to enforce the Congregation's Laws. 'In 1826, when Moses Solomon held services in his own house, the malcontents were punished by having to pay a tax of 1d per pound on meat from the Congregation's butchers'. (Josephs, Birmingham Jewry II, p. 8) A Meat Committee is mentioned in the Congregation's Annual Report of 1854 (see JA/2/G/2) and its reports appear in Council minutes in 1866 and 1878.

In 1891, a sub-committee of the Council of the Congregation was appointed to organize the supply of kosher meat, called 'The Committee for Superintending the Affairs of the Shechitah', the 'Committee of Superintendence of Shechitah' or 'The Shechitah Board'. The history of the Birmingham Hebrew Congregation notes that 'In 1892 the superintendence of the affairs of the Shechita was relegated to a Special Committee, with Albert Bremer as its first President, and the laws of the Congregation were altered for the permanent establishment of the same.' (Levine, History of the Birmingham Hebrew Congregation, p. 26.) In 1920, the Committee was dissolved and replaced by the Birmingham Shechita Board.

The Board, set up on 27 April 1920, was made up of representatives from three synagogues in the city: Singers Hill; the Wrottesley St Beth Hamedrash (later the Central Synagogue); and the Beth Hamedrash, Holloway Head. The Board's reports appear in the Congregation Yearbooks. According to the 1929 Yearbook, the Board comprised a Chairman, Treasurer, three Trustees, two clerical advisers, a committee of 13, and a Secretary. The reports usually include a balance sheet showing income and expenditure and staff superannuation, a report about inspections of butchers' shops, statistics showing the number of cattle killed kosher and trefah, and a list of kosher butchers and poulterers licensed by the Board.

The Laws of the Board, which appear in the minutes of its first meeting on 27 April 1920 and include the following laws:

- 1) That [the Board's] objects be the supply of Kosher Meat and Poultry to the Birmingham Jewish Community and the exercise of authority over all Butchers and Poulterers supplying Kosher;
- 2) That the Board be constituted on the basis of one representative for each complete eighty seatholders of the following bodies: Singers Hill Congregation, Wrottesley St Beth Hamedrash and Holloway Head Beth Hamedrash;
- 3) That the Minister of Singers Hill and the rabbis of Wrottesley St and Holloway Head are exofficio members:

The President and Treasurer shall be elected at the first meeting held after the election of the

new Committee by nomination and show of hands;

- 11) All real and funded property of the Board shall be conveyed to and invested in the names of three Trustees;
- 15) The Secretary shall devote such time as is necessary for the efficient carrying out of the business of the Board and shall generally be under the directions of the President or in his absence the Treasurer. He shall keep books of account to the satisfaction of the Board. He shall conduct the correspondence and present copies of all letters. He shall attend all meetings and issue the notices for such meetings and keep minutes of the proceedings thereat. He shall prepare an Annual Statement of the accounts of the Board with a Balance Sheet of the Income and Expenditure up to Dec 31st in each year and submit the same to the Auditors and to the Committee as early as possible thereafter;
- 18) A Banking Account ...shall be kept in the name of the President and Treasurer;
- 19) all moneys received by the Board shall be paid into the Banking Account and all payments shall be by cheque only...signed by the two in whose names the account stands;
- 23) Shochet must hold the kabbalah of the London Ecclesiastical Authorities.' Creator of the material: Birmingham Shechita Board

The collection has been arranged in chronological order.

Minutes of meetings of the Birmingham Shechitah Board and its predecessor, the Committee for the Superintendence of Shechita, ledgers, cash books, and invoices. The archive deposited by the Birmingham Hebrew Congregation contains material from a number of Jewish organizations. Most of the material relates to Singers Hill Synagogue, but there is also a small collection of records from the New Synagogue, Park Road, which merged with Singers Hill in 1997. The archive also contains records of the Birmingham Jewish Arts Society (MS 2520), Birmingham Youth Council (MS 2522), Young Israel Council (MS 2523), Birmingham Shechita Board (MS 2529) and Birmingham Hebrew Educational Aid Society (MS 2539), and the personal papers of the historian Zoe Josephs (MS 2524). The personal papers of Dorothy Gillman (MS 2525) and Constance Davis (MS 2526) were also deposited by the Congregation.

Other collections held by Birmingham City Archives which may be of interest include Birmingham and District War Refugees Fund (MS 652), which includes minute books, registration forms, and correspondence, and may include information about Jewish refugees; records of Henry Yeoville Thomason (MS 1460), which include architectural drawings of Singers Hill Synagogue; personal papers of CB Lander (1904-1989), including family papers about naturalization, Jewish friends, and Jewish affairs and history (MS 1515); microfilms of minutes of the Birmingham Hebrew Philanthropic Society, the Birmingham Hebrew Educational Aid and Clothing Society, the Ladies Benevolent Board, and the Board of Guardians (MS 1678); and papers of Dr Carl Chinn (MS 1902), which include material about the Jewish community in Birmingham, including some autobiographies.

Birmingham Central Library Local Studies and History holds material about the Jewish community including a set of Birmingham Hebrew Congregation Yearbooks, 1913-1971; an Order of Service held to celebrate the opening of the Birmingham Hebrew School at St Luke's Rd, Edgbaston, May 1, 1932.

recruitment, and salaries of butchers, granting licences to sell meat to the Jewish community, settling disputes, inspecting butchers' shops, and elections of Committee

members. Not all the butchers are Jewish. The

Committee acts when the food laws have been infringed: the minutes of 20 February 1898 include discussion about a case of a butcher selling unporged joints of meat to Jewish customers and a meeting of 1 December 1895 orders that the door between a pork shop and a butcher's shop be bricked up. The Committee's Income and

Expenditure Account and the Congregation's Report and Balance Sheet, which includes a short report about the Committee's work, are enclosed in the later minutes. The minutes also include copies of correspondence asking the Chief Rabbi's advice, and correspondence with the

superintendent of the Birmingham City Meat Market, giving

the Board permission to use Birmingham City's

slaughterhouse between 8.00 and 10.30 am on Sundays.
