# MS 2009. Birmingham Trade Union Resource Centre. 1983-1996.

Trade Union Resource Centre Ltd [TURC] was formed in 1982, as a research and information service for trades unionists and political campaigners. It was one of a number across the country, which developed partly in response to the needs of trades unions at a time of profound change, and partly as a consequence of new approaches to campaigning within the labour movement.

TURC was formed by Birmingham Trades Union Council [BTUC]. The articles of association established TURC as a company limited by guarantee, without share capital. This separate legal identity was intended to protect BTUC from any liability arising from the Centre's activities. Funding was provided by West Midlands County Council [WMCC]. This model of Trades Council involvement but with local authority funding continued throughout TURC's existence. It set the tone for many of TURC's activities, as it focused on economic issues and also social injustices including discrimination. However, this model also provided much tension within TURC and between TURC and other elements of the labour movement.

From the outset, the Trades Union Congress [TUC] was against the creation of resource centres in general and TURC in particular. TUC Circular No. 71 (1981/82) stated that no TUC body should establish a resource / research centre and should not participate in discussions leading to the creation of such centres. This was because of a concern that alternative trade union structures should not develop, without being fully accountable to trades union hierarchies and the TUC.

After much deliberation, BTUC decided to pursue the creation of TURC. The availability of local authority funding initially gave BTUC the means to create and develop TURC. Ultimately however, a dependence on public funding led to the failure of TURC, as Central Government progressively restricted the types of activity that local authorities could support. In addition to legislation against "campaigning on the rates", local political priorities also altered over time. With the abolition of the WMCC in 1986, Birmingham City Council [BCC] assumed responsibility for TURC. Despite attempts to attract funding from other local authorities, public bodies and trades unions, the City Council remained the major source of income.

Continued legislation into the 1990s to control public support for voluntary organisations affected the levels of and conditions attached to BCC funds. This period also saw a qualitative change in BCC responses to economic development. Funding was now targeted at projects that could demonstrate a progression to employment or higher level training. A separate Council department was formed to promote and sustain economic regeneration, and whilst responsible for funding voluntary sector organisations, it also promoted structural change within Birmingham's economic base. This Economic Development Department [answerable to the Council's Economic Development Committee] acted to cut back TURC's funding to its [original] core functions of research and information services. The Publishing, Print and Video subsidiaries were closed, with the print and video operations being transferred to a newly formed Birmingham Centre for Media Arts [BCMA], funded jointly by BCC and West Midlands Arts and which merged the production facilities of TURC, Wide Angle Productions and WEAVE.

Funding crises continued and intense lobbying of BCC occurred, by BTUC and individual trades unions. This quest to secure sufficient funding was a constant feature of TURC's existence until its closure in 1996. An unsuccessful attempt was made by TURC to claim

charitable status in order to gain tax relief, but the Gilliver Charitable Trust was established in 1992. A "Save TURC" campaign was also launched in 1992 and was adminsitered from the Centre.

A fundamental requirement was for suitable premises for TURC to operate from. The Centre commenced operations in 1982 at 73/5 Pershore Street, but soon moved to the Gough Street premises of the Union of Construction and Allied Trades [UCATT]. In 1983 the Centre relocated to the Victoria Works, 7 Frederick Street, a building that would become synomous with TURC. by 1990 however, funding difficulties and disputes with the landlords of Victoria Works led to a further move being considered. BTUC wished to centralise its various operations in one building, and BCC offered Digbeth Civic Hall for rent. This proposal generated tensions between TURC Management Committee and staff. The move to Digbeth did not occur, and in 1994 TURC leased part of the MSF premises at 70 Lionel Street. This was shortlived however, and later that year TRUC moved to BTUC's Trade Union Club, Pershore Road, Selly Park, where TURC remained until final closure.

A key feature of TURC was the close relationship that it had with a number of bodies, some formal, others less so. As fellow organisations supported by BTUC, TURC worked closely with Birmingham Centre for the Unemployed, the West Midlands Health Monitoring Unit and the Health and Safety Advisory Centre [HASAC]. TURC even shared accommodation with some of these organisations at different times, but retained a separate identity, under the BTUC umbrella. The South African Monitoring Service [SAMS] provided a good example of the close links that TURC had with formal institutions and campaigning groups. SAMS was based in the TURC premises at 7 Frederick St, and operated in conjunction with Birmingham Anti-Apartheid, BTUC and TURC. It aimed to generate & supply information on West Midlands companies' links with Apartheid, to follow up and supplement the TURC booklet "The Apartheid Connection".

TURC had a more direct relationship with the Youth Employment and Training Research Unit [YETRU] however. Established in 1984 by BTUC (with WMCC funding) it was originally known as the Youth Training Scheme [YTS] Research (Monitoring) Project. Through research, campaigning & advice work it aimed to highlight & address the effects of un/employment and training on the lives of young people (16 - 25). YETRU was particularly concerned with the prevalence and adverse effect of racial discrimination within the youth training schemes. YETRU workers were nominally employed by TURC, but reported to a separate management committee until 1989, at which time a joint TURC / YETRU Management Committee was formed. YETRU continued as a discrete unit until 1992, when TURC directly undertook an element of work around issues affecting young people until 1996.

A less formal, but similarly close relationship developed between TURC and the Trade Union Research Network [TURN]. TURN was initiated by research workers at TURC to establish a network of individuals with skills and knowledge, who would be prepared to act as consultants on issues such as company accounts or trade union law. It was also seen as a means of encouraging individual and collaborative research that would be of direct use to the trade union movement. The relationship between the TURC Management Committee, TURC Publishing and TURN was close but not always calm. TURN had independent structures and decision making processes, and did not regard itself as an integral part of TURC. This did not sit comfortably with some BTC nominees to the TURC Management Committee, who wished TURC Publishing to undertake specific projects requested by the BTC.

This collection was primarily assembled by TURC staff in the course of their duties. The material was collected from the Trade Union Club by Paul Mackney after TURC's closure and deposited with the City Archives.

Further small accessions donated by individuals are recorded at the appropriate file entry.

These records have been treated as a single entity as the articles of association of the various companies within the TURC group preserved the concept of a common purpose and the ability to function as a collective. Similarly, although the Youth Training Services Monitoring (Research) Project (later YETRU) initially operated at arms length, TURC were directly involved from the outset, later assuming complete responsibility.

Naming conventions are in accordance with the [U.K.] National Council for Archives Rules for Personal, Place and Corporate Names (NCA "Rules")

This collection illustrates both the formal, organisational aspects of TURC and the operational details of the Centre. It also reflects the fact that TURC was part of a dynamic and complex network of social and political activists and conventional and more radical campaigning groups.

The records have been arranged to reflect the evolution of TURC from a single research and information service for trades unionists and campaigners, into a formal group of associated companies. These records also generally fall into discrete types of administrative and financial records, such as minutes, ledgers and correspondence files. A conventional archival

arrangement has therefore been adopted to reflect the organisation and operations of TURC and its constituent parts over the period of its existence.

In addition to the constant struggle to obtain sufficient funding, TURC's requirements under company law and its trading activities with regard to publications, video and print production have resulted in the collection containing many financial records and correspondnece about accounts and funding. Other practical considerations that loom large in the records include employee relations and building issues. As an employer as well as a trades union body, TURC worked within accepted procedures for dealing with employee issues. As the Centre's funding situation worsened, redundancy procedures joined standard renumeration deliberations between the Management Committee and staff representatives. With regard to building issues, correspondence relating to tenancy issues such as car parking and routine repairs and maintenance are later joined by lease negotiations, insurance claims and papers concerning court disputes over damage to TURC property and equipment by contractors. TURC's operational activities are recorded, for research and informational services, as well as the publishing, print and video activities.

These records describe the reality of operating a centre such a TURC, but they also cast light on the activities and concerns of TURC, at a time of profound economic, social and political change. Industrial relations disputes such as the 1984 Miners' Strike and political confrontations such as the imposition of the Community Charge "Poll Tax" were regarded by many as "legitimate" areas for an orgnisation such as TURC to concern itself with, even if Central Government legislated to reduce the extent to which public funds could be used. However, TURC also addressed issues of discrimination in the workplace and in society (within the West Midlands and further afiield). The records of TURC should therefore be considered against a backdrop of concerns over disrcimination on grounds of gender, race, disability and sexual orientation, disaffection and disturbance in many cities [as with the Handworth disturbances of 1985], campaigns against nuclear weapons, anti-deportation campaigns and so forth The impact of the Prevention of Terrorism Act was a major concern both of BTUC and TURC, as was the apartheid regime in South Africa.

Whilst TURC's official activities may have been channelled into "mainstream" trades union issues by legal and funding restrictions, concerns with such wider issues both informed the general outlook and tone of TURC, and also manifested themselves where opportunities permitted. TURC's "production" elements [Publishing, Print and Video] with their [albeit limited] capacity to attract independent sources of funding were able to undertake "campaigning" activities. They also reflect a concern within TURC to embrace opportunities offered by media contacts. Throughout this collection are references to services provided to mainstream organisations such as the BBC as well as 'progressive' operations such as Tariq Ali's Bandung Productions. Familiar labour movement fears of press bias sit alongside the commissioning of works to assist trades unionists in engaging with the media.

The arrangement adopted for this collection reflects the fact that TURC fitted into the formal structures and operating protocols of the established labour movement. However, TURC also developed and maintained informal links with the emerging campaigning and direct action movement, which is reflected in the contents of this Collection. This blend of the formal and the less formal should be considered by researchers, who will benefit from studying related collections. The official records of BCC, BTC and WMCC will provide particular insights into relations with, and issues affecting TURC. Birmingham Labour Group records, and the personal papers of Sir Richard Knowles and Paul Mackney [Leader of BCC and President of

BTC respectively at crucial times for TURC] will further illuminate the political dimension in which TURC operated.

Various records relating to the same subject may be found across a range of record types, and researchers will often be rewarded by referring to all elements of the collection, even if the headings do not immediately indicate a relevance.

### MS 2009/A. Birmingham Trade Union Resource Centre . 198? - 1996.

The central element is the TURC Management Committee [from 1989 a combined TURC / YETRU Management Committee]. This was the governing body for TURC, to which staff were accountable. It set policy and authorized expenditure. It also served as the Board of Directors, under company law. The composition of the Management Committee reflected the origins of TURC as a labour movement body, funded by local authorities. From 1982, Management Committee members were nominated by Birmingham Trades Council, with positions reserved for the West Midlands County Council [as funder] and the West Midlands Regional TUC. This latter provision was intended to allay fears by the TUC that TURC would operate outside of the conventional trades union structures. However, the offer was never taken up, the national TUC Council preventing the Regional TUC from becoming involved.

Over time, the Management Committee's composition altered slightly but the main pattern of trades union involvement, channelled primarily through the BTUC remained, along with representation of the funders. The relationship between TURC and BTUC whilst close was sometimes turbulent, and as the main link between the two, the Management Committee both experienced and contributed to tensions. In addition to the normal industrial relations issues between the Management Committee and the Centre staff, there were fundamental differences between how the BTC and TURC staff viewed what legitimate workloads should be. Formal lines of authority from the BTC Executive Council, via the TURC Management Committee and Centre co-ordinator to staff did not always sit well with a workforce used to exercising initiative, and operating in an environment where direct, independent action was increasingly valued. Tensions arose between TURC and individual trades union hierarchies, where TURC's emphasis on providing information and support services to grass roots trades unionists was viewed as potentially compromising the negotiating positions of paid union officials.

This standpoint was not universal with trades unions, and over time TURC gained and retained support from many union branches. There remained however a clear distinction between the BTC view of TURC as an [arms length] agent of BTC policy and TURC staff's attempts to retain a capacity for independent decision making. Such tensions surfaced throughout the Centre's existence, over issues such as the BTC desire to relocate TURC into a single Trades Council operation at Digbeth Civic Hall, and the requirement that TURC produce the BTC journal, which had previously been produced separately. This latter issue brought the relationship between TURC and TURN into sharp focus, as some members of the BTC Executive Council regarded TURN as a "front" for TURC staff seeking to follow an independent line.

A further factor was the funder's representation on the Management Committee, as BCC increasingly sought to direct the activities of TURC through Service Level Agreements for specified research and information services, and divestment of the specialist subsidiaries of Publishing, Print and Video. This aspect brought to the fore the inter-related nature of the local labour movement, with Michael Joseph [Mick] Rice serving simultaneously as Secretary of BTC, Chair of TURC Management Committee and Vice Chair of BCC Economic Development Committee.

The worsening funding situation and the enforced restructuring brought to the fore the Management Committee's role as employer, as negotiations with staff trades unions moved away from salary issues and terms and conditions towards redundancy.

There were also internal tensions between staff members. The Trades Council's decision to merge its management responsibilities for TURC and YETRU in 1989 caused local difficulties, as teams that had previously regarded themselves as distinct, though co-located units now operated much more closely as a single unit.

This section is the heart of the collection, as it contains records of the original research and information service established in 1982, and also those of the holding company created in 1986, to co-ordinate the specialist subsidiaries of Publishing, Print and Video set up at that time. From 1989 the joint management arrangements for TURC and YETRU are also recorded here, as are post 1992 details, when TURC reverted to a research and information service, with closure of YETRU and the specialist subsidiaries.

A wide range of material is contained, including minutes and related papers, financial and operational records, correspondence between TURC and a wide range of parties, as well as publications produced by TURC and by other organisations.

These records offer a comprehensive insight into the motivation behind the establishment of TURC, and its development over time. The social, economic and political landscape in which it was placed is shown, as are the often intricate relationships which key members of TURC had with various elements of the labour movement, and the tensions that arose. Individuals with differing political [but socialist] affiliations were involved, sometimes in a personal capacity, but sometimes as representatives of the Labour Party or other socialist political organisations, individual trades unions, Birmingham Trades Council and the Trades Union Congress. Campaigning groups on a range of topics were also involved.

The organisational role of TURC is more apparent in the minutes and finances, and the campaigning role is more readily identified in the correspondence and publications sections - but this is not a hard and fast rule.

### MS 2009/A/1. TURC Ltd Minutes (and related papers)

This series was established as an administrative tool, rather than for governance purposes. Therefore, the minutes do not constitute a formal series of signed copies and there are some gaps in the sequence. However, the inclusion of supporting papers from a range of sources permits a good overview of the issues facing the Centre over time.

The main set of minutes contained in these files relates to the TURC Management Committee, which from 1989 became the combined TURC / YETRU Management Committee [but still periodically referred to as just the TURC Management Committee]. This is a relatively complete series with minutes of regular, scheduled meetings as well as the obligatory annual general meetings and special meetings as required. In addition, a range of other minutes is contained, often included as supporting papers for agenda items, but sometimes filed as stand alone items. Such minutes include those of staff meetings and consultative meetings between the Management Committee and staff trades unions. Minutes of the "Save TURC" campaign also appear, as do occasional minutes of the BTUC Council and Executive Committee, where they contain items specifically relating to TURC.

In addition to such minutes, supporting papers also include reports and correspondence. The role of the Management Committee as a board of directors for TURC ensured that a steady stream of financial and operational reports from TURC Publishing, TURC Print and TURC Video was considered by Management Committee and is retained in this series. Correspondence between the Management Committee and West Midlands County Council, Birmingham City Council, BTUC and TUC is also contained.

The Management Committee formed a Staffing subcommittee and also a Finance Sub Committee [sometimes referred to as the Finance Committee]. Copy minutes for these are attached as agenda items with the main Management Committee minutes. These are very useful, but a full sequence is not retained, and they are included purely as additions.

Occasionally, minutes of the BTC Council and Executive Committee are included, where they contain decisions directly affecting TURC.

Financial and Policy Approval forms regularly appear in this series, submitted by staff from all parts of TURC. They were a device to keep staff in line with BTUC wishes, as expressed through the Management Committee. The range of subjects covered provides an insight into the operational environment and concerns of TURC staff, as although they reflect exceptions to routine practice they also deal with relatively low level matters. Major policy issues would be handled by reports or presentations to the Management Committee.

The reports and correspondence may be partial duplicates of material held elsewhere, particularly of the subsidiary records but are retained in this sequence because of the context that they provide the Management Committee minutes.

### **TURC Minutes & Related Papers**

1986-1989

Whilst the original title of this file "Minutes of TURC Management Committee" does not fully represent the range and nature of the records contained, it does reflect the rationale for creating the file. The file is organised around the agendas for specific Management Committee meetings, with supporting papers appended.

This file focuses on operational aspects of TURC, rather than its campaigning role. Glimpses of this role are provided however by the supporting papers.

These supporting papers include the minutes of previous Management Committee meetings, and minutes of associated meetings, which are summarised below.

Reports, financial statements & accounts and correspondence concerning TURC business are also contained. Again, these are summarised below.

Collectively, these papers reflect the company structure of TURC, and the relationship between the various components of TURC, and the relationship between TURC and Birmingham Trades Council, as well as with various constituents of the Trades Council, such as YETRU and the NHS Monitoring Unit. An insight into some of the activities undertaken by TURC is provided, as are the sometimes conflicting attitudes and approaches of Management Committee and the staff to issues facing TURC., for instance over the process of merging TURC and YETRU.

This file contains some partial duplicates of items included elsewhere, but they provide a different context for this file, and are therefore retained.

Papers in this file are in general ascending but not strict chronological order (The earliest records are generally at the rear of the file, rising to the latest at the front). This general chronological order partly reflects the nature of the records, which are an accumulation of papers considered at, or in support of business meetings. Individual papers are related to specific meeting agendas, and are assembled in the order dictated by the agenda, which may not be in strict date order.

Two separate numbering systems are in place: The first sees every sheet numbered consecutively from 1 to 118 (1986 - [March?] 1987), but with a gap between 73 and 83. The missing papers may relate to the proposed

Acquisition of Digbeth Civic Hall (Agenda for 17th February 1987 refers (86 in chronological sequence) However, there are two sets of handwritten (draft) Management Committee minutes (for 16/09/1986 & 16/12/1986) that are not included in the numbering sequence, yet are interleaved within the sequence. The final typed versions are numbered in sequence. Please note that handwritten (draft) minutes for 17/2/1987 are included in the chronological sequence (90 - 95)

The second numbering system covers June 1987 to May 1989 and is agenda specific. For each agenda, the supporting papers are annotated against the relevant agenda item. This annotation is sometimes by number, sometimes by letter. Whilst all agendas in this date range are annotated (either by typescript or in ink) not every set of supporting papers is annotated, and some enclosures are not specifically referred to on the agenda. Some at least of these may have been tabled at the meeting itself.

Papers covering the period [March?] 1987 to May 1987 do not fall within any sequencing system, indicating an interim period between file creators. Prior to [March?] 1987, calling papers and agendas were circulated by Annette Sandy (Administrative Assistant / Clerical Worker) or Mick Rice (Chair of TURC Management Committee). Between [March?] and April 1987, Mick Rice and Geraldine Egan (Vice Chair of Management Committee) issued such papers. This reflects the lack of a Centre co-ordinator. From May 1987 until May 1989 Geraldine Egan, as Centre Co-ordinator issued calling papers and agendas, the second form of referencing reflecting this change.

#### **TURC Management Committee**

1994 - 1995

This folder covers a critical period in the development of TURC. Both routine business papers are included (notices of forthcoming Management Committee meetings, agendas and copy minutes) as well as details of fundamental importance. Records include correspondence of the Chair and Secretary with Management Committee members, trades unions, local councillors, the media etc concerning developments at TURC, disagreements within the Management Committee, and between the Management Committee and staff, The City Council and others. Tension is noted around the degree of TURC's independence (or otherwise) from the Birmingham Trades Union Council. Reluctance of the City Council to continue funding is also detailed. Allegations of impropriety are made against officers of TURC. Reference is made to a City Council Audit investigation into TURC s finances, undertaken at the request of TURC's Secretary. Details of unauthorised approaches by individuals to the University of Warwick with a view to establishing a "new" TURC independent of BTUC are included. Practical matters relating to the move of premises from the MSF premises in Lionel Street to the Union Club, Pershore Road are detailed, as are Council and other concerns at the implications for TURC of this move.

The contents of this file were originally stored in individual plastic pockets. The papers have been removed from these pockets for conservation purposes. However, as certain papers had been removed from their pockets prior to being deposited with the City Archives, the cataloguer has indicated where these empty pockets were in relation to remaining papers in the folder.

Please note that during the currency of this file Mick Rice was simultaneously the Secretary of BTUC, TURC & the Union Club and also a Councillor for BCC (serving as Deputy Chair of the Economic Development Committee).

### MS 2009/A/2. TURC Ltd Financial Records. 1982 - 1994.

As a company limited by guarantee, TURC was governed by company law and had to keep appropriate financial records and also submit audited accounts to Companies House. This series contains the ledgers, bank statements etc for the Centre, initially as the sole company and from 1986 as the parent company of the TURC subsidiaries. YETRU and the subsidiaries also maintained financial records and submitted financial reports to the Management Committee and this series should therefore not be considered in isolation from the rest of the collection. They do however provide a useful overview of the operational issues and campaigning interests of TURC [or at least those generating income or causing expenditure].

### MS 2009/A/2/1

### BTURC Income & Expenditure Ledger

1982-1984.

This ledger covers TURC's formative period, running from January 1982 until March 1984. {Entries for April 1984 are also recorded, but annotated as being transferred into a new ledger – MS 2009/A/2/2]. The ledger records the practical issues of setting up the Centre, including the initial grant allocation [from WMCC] and costs of recruiting staff.

The ledger is organised into two sections; [revenue] income and expenditure and capital expenditure. Both sections are divided by month and year.

The main source of income was WMCC grant, with small donations and payments from subscribing sponsors also being listed. These sponsors were primarily political party groups and local trades union branches. As time progresses, income from services and productions are recorded, such as videos and print jobs.

The main revenue expenditure was salaries and staff expenses, followed by building service costs. Capital expenditure included office and production equipment and building works.

Interleaved with this ledger are three letters from TURC to WMCC Economic Development Unit. These letters [dated 10/02/1983, 03/03/1983 and 24/03/1983] detail capital items paid from the TURC revenue account and request that funds be transferred accordingly.

### MS 2009/A/2/2

### **TURC Income & Expenditure Ledger**

1984 - 1987

This ledger was originally called the TURC Main Ledger. It commences in April 1984, indicating the adoption of local authority financial years – April to March. The first few entries have been copied from MS 2009/A/2/1. The ledger covers TURC's transition from a single entity to a group of related companies.

[Revenue] income and expenditure is recorded by month. Income sources are similar to those recorded in MS 2009/A/2/1, with grants from BCC replacing those from WMCC from May 1986 onwards. Expenditure also follows the pattern described above.

The last entries in this ledger record expenditure in April 1987, but these have been scored through and are repeated in MS 2009/A/2/3

## **Centre Opening**

1983

This file is concerned with the preparations for the Official Opening at the Victoria Works, 7 Frederick Street which was held on 16th March 1983. Councillor Geoff Edge, Chairman of the WMCC's Economic Development Committee and Councillor Gordon Morgan [Leader of the Labour Group on WMCC] officiated and a display of TURC's work over the preceding few months was provided. [TURC commenced operations in 1982, initially at 73/5 Pershore Street and then at the Gough Street premises of UCATT.]

Taken as a whole, this file provides evidence of the people and organisations that were regarded as important to TURC in its formative period. Invited guests were primarily drawn from local campaign groups and trades union branches and guest lists are included. The file also contains a sample invitation letter from BTUC on behalf of TURC, as well as replies confirming attendance or submitting apologies. [Some of these replies were in the form of telephone message notes.] Some correspondence between the TURC co-ordinator and BTUC about the arrangements are also included.

A sample leaflet about TURC services is included, as are two types of TURC advertising postcards. These were intended to be posted to contacts and the first is a notice about relocation to Frederick St [with some details printed in red]. The second is an invitation to the Official Opening itself. Both examples are printed with the TURC logo [in colour] on the 'picture' side. This was a product of the TURC Design Project, Lanchester Polytechnic [Coventry]. Both types were published by TURC.

A number of letters of thanks are contained in this file, including some from officers of UCATT, for gifts presented to

them at the official opening in recognition of support and accommodation provided to TURC.

Four black and white photographs taken at the reception after the Official Opening are included. These were not initially annotated, but partial identification has been made by the cataloguer and the photographed labelled accordingly.

Two examples of each unused sample item have been retained in this file, together with all annotated examples. All other unused duplicates have been weeded and disposed of in accordance with the wishes of the depositor

1991

This emanated from the employees of TURC and identified existing 'products' that TURC offered, as well as potential new products. The Development Plan adapted contemporary marketing terminology to TURC's particular situation. This contrasts with the more formal approach of the subsequent Application for Funding [Ms 2009/A/3/3] and other communications with BCC, BTUC etc. The Plan reveals imaginative thinking about TURC with optimism for the future and a bound copy was submitted to BCC as part of the funding application process. This generated queries from the City Council's Economic Development Department [see MS 2009/A/3/3] and a warning that more realism about the level of grant on offer to TURC was required.

Service Level Agreements [SLAs] were progressively introduced by BCC during the 1990s. Originating in the Social Services environment, they required recipients of grants to specify the type and quality of service that would be provided in return for funding. For voluntary and community based organisations, SLAs replaced (but incorporated) the grants with associated conditions previously used.

The key record in this file is a letter to the TURC coordinator from BCC Economic Development Department [dated 15/05/1991] concerning the need to agree an SLA to release funding. Attached is a list of observations and questions on the Development Plan [MS 2009/A/3/2] and other information previously submitted by TURC. An outline of the structure and scope of SLAs is also included.

Also within this file are photocopies of reports produced by BCC EDD. The 'Economic Development Committee Strategy' [dated 19/12/1990] and 'Voluntary Organisations' [21/12/1990] appear to have been used for reference by TURC in preparing documentation for submission to the City Council. Also included is a chart entitled 'Business Investment and Enterprise: Business Support' [nd]. This shows projects supported [including TURC] with 1990/1991 [budget] and 1991/1992 [Estimate].

The final set of papers in this file relates to concerns regardig SLAs of voluntary organisations within Birmingham. A list of groups invited to a meeting about the subject together with notes of the meeting held on 05/06/1991. Also attached is a list of relevant publications.

#### **TURC Application for Funds from BCC for 1991/1992**

1991

This is a detailed application for funds made to the Economic Development Committee of Birmingham City Council for Financial Year 1991 / 1992. It followed a formula favoured by the City Council and reflected a need to demonstrate that TURC matched the funding criteria set by BCC and imposed by Local Government legislation.

This application provides a good overview of the services provided and activities undertaken by TURC, as well as the financial and operational pressures faced at that time. It should be borne in mind however that this application had a specific purpose in attracting funding and therefore places emphasis on certain aspects of the Centre's activities that

were deemed likely to find favour with the funders. The role of BCC representatives on the TURC Management Committee should also be considered, as advice on what was likely to be approved or disallowed was provided before formal applications were submitted. This application should therefore be read in conjunction with the Management Committee minutes and associated papers and the correspondence files for this period, to place it in context.

## MS 2009/B. Youth Employment and Training Resource Unit (YETRU). 1986 - 1992.

The YTS Research (Monitoring) Project was formed in 1984 with funding from West Midlands County Council. Through research, campaigning & advice work it aimed to highlight & address the effects of un/employment & training on the lives of young people (16 - 25). YETRU was particularly concerned with the prevalence and adverse effect of racial discrimination within the youth training schemes.

For reasons of administrative convenience, workers were nominally employed by TURC, with powers of management delegated to a separate Project Management Committee, nominated by Birmingham Trades Council. Whilst designated as a sub-committee of the TURC Management Committee, this Project Management Committee's membership consisted of 3 WMCC councillors, 1 representative from Birmingham Trades Union Council and 1 from TURC Management Committee. These all possessed full voting rights, and a place for a delegate from the Regional Trades Union Congress was available, although not taken up. A representative from the Campaign for Racial Equality in MSC Programmes [CREMP] also attended, but without voting rights. This pattern altered over time, but retained the core pattern of BTC and funder representation.

TURC amalgamated YETRU into the Centre's management structure in 1989. This was undertaken as a device to reduce the workload of representatives of Birmingham Trades Union Council who had previously attended separate management committees for TURC and YETRU. Funding and recruitment / retention difficulties led to the Unit's closure on 31st March 1992, TURC then directly undertaking an element of work on issues affecting young people.

Some are for assistance with specific events such as the Hotel and Catering Industry Workers' Conference organised by the GMB [16/02/1988] and a sexual harassment workshop for the Women's Forum of the Astons' Student Guild. [22/11/1991]. Other letters of thanks cover media support, including 'Life school: they always say No' for BBC School TV [06/01/1989] and 'Action Special' for BBC Radio One [03/05/1990].

In addition, this file contains requests for employment at YETRU. A notable set of papers considers a request for employment from an Australian [05/01/1990]. Enclosures include a curriculum vitae & employment references and offer an insight to education patterns and concerns of the voluntary sector and campaigning groups in Australia.

# MS 2009/C. TURC Publishing Ltd. 1985 - 1994.

TURC Publishing was established in 1985 as a functional unit, to develop a sizable publishing and distribution operation as an asset for the whole Centre. In September 1986 it became a formal subsidiary of TURC Ltd as part of a major restructuring of the Centre. TURC Publishing Ltd was a company limited by guarantee and was set up to publish & distribute materials originating within TURC, within the Trade Union Research Network [TURN] or with outside bodies that it chose to distribute. The directors of TURC Publishing were nominees of the TURC Management Committee. This new structure was adopted, to protect as much as possible the assets and operations of TURC Ltd, in case legal action was taken for libel or under the Local Government Act against the publishing activities of the Centre. The legal status of TURC Publishing Ltd was similar to that of the similarly created TURC Video Ltd & TURC Print Ltd.

The personnel for TURC Publishing were initially drawn from within the main Centre, and retained their core duties. They were augmented however by members of TURN, who in addition to providing information also assisted in editorial work.

TURN was established to bring like minded individuals with research & other skills together with trade unionists and others. It was initiated by TURC research workers, and the relationship between the formally structured TURC and the less formal network was close. A regular report on the work of TURC Publishing, including individual publications and overall finances was required from the publications worker to the TURN Editorial Group. This report was also to be made to the TURC staff meeting, and where significant political & financial departures or commitment were involved, to the TURC Management Committee.

The TURN Editorial Group was a voluntary group elected from TURN general meetings plus co-optees. Its role was to ensure overall co-ordination of TURN and groups within the network. It worked collectively to discuss & administer such business as the growth of the Network, methods & priorities of publication & distribution of research work, finances, and communications from other groups etc. The group included TURC researchers, Network members and a publications / distribution worker. Any member of TURN was welcome to join the Group.

However, it also had responsibility for content of publications via a "contact / reader" system, and responsibility for the overall direction of publications including print runs & distribution. This assumption of a right to direct operations within TURC Publishing indicates a source of tension between the two bodies. Whilst TURC staff may be happy to have a counterpoint to the Management Committee, this Committee and the directors of TURC Publishing Ltd had defined responsibilities under company law. In contrast, TURN had no formal mandate to intervene in TURC's affairs and was dependent on the co-operation of TURC staff. Tension arose over the production schedule, with the Management Committee expecting TURC Publishing to produce the BTC Journal as instructed, and TURN seeking to influence this production schedule.

The impetus for a formal publishing operation had been a recognition that within the West Midlands, there was a need for an independent left pamphlet publisher which provided a service outside of specific interest groups (e.g. West Midlands Low Pay Unit, CND) & cheaper,

better designed and shorter than Pluto Press). An editorial policy was set that the envisaged series of pamphlets was not to have a specific line, Series of pamphlets was not to have line, other than being a non-racist, non-sexist, pro-working class one whose aim was to produce popular pamphlets at £1.00 or less written at a level between that of the Daily Mirror and the Guardian.

# TURC Publishing Ltd Accounting Records

This book was originally labelled 'Bank Ledger'. However, it contains five sections. December 1985 to March 1986 forms a cash book, with monthly receipts and payments being recorded. From April 1986 to September 1987 income only is recorded, but with annotated comments and figures added.

The format changes to a bank ledger between April 1990 and October 1992, where details of individual cheques banked are recorded. There is also a section for outputs and inputs from April 1989 to September 1991 for VAT accounts, together with a note of items that are not included in Total Sales and Purchases.

The final section records income and expenditure for April 1992 to March 1993, although no expenditure is occurred between November 1992 and March 1993.

Interleaved is a remittance advice slip from Leeds City Council dated 10/02/1990.

This book is labelled 'Sales Day Book' and is divided into two sections. The Purchase Daybook covers December 1985 to July 1987. It contains an analysis of the total amount for each entry.

This report reflects the collaborative nature of TURC and YETRU. The report was produced by YETRU and published by TURC Publishing. The majority of the photographs used in the report were taken by George Makin, an employee of TURC.

The Report was printed by the Russell Press (TU) of Nottingham and financial assistance was provided by the Barrow and Geraldine S. Cadbury Trust.

The report highlighted racial inequality within the Youth Training Scheme, both within the West Midlands and nationally. Individual companies were highlighted as being responsible for such inequality and the Training Commission was criticised for failing to properly regulate equal opportunities amongst training providers. MS 2009/C/4/4 The People's Century: Birmingham 1889 - 1989

The Birmingham Labour History Group [BLHG] compiled this alternative view of Birmingham's history. It was published by TURC to co-incide with the official celebrations and publications sponsored by BCC to mark Birmingham's centenary as a City.

This publication illustrates the inter-relationships within the local labour movement. The BLHG began as an evening class at Birmingham Trade Union Studies Centre and some members of the Group were also members of TURC and / or TURN.

This was a company established by the three authors to protect TURC from possible legal action. Roger Kline was a researcher with TURC and the other authors had connections with Dudley.

The booklet was concerned with the impact of privatisation on local council services. The Conservative controlled Dudley Council was regarded as a pioneer in this field and was praised by the Party's Central Office. The authors investigated the policies and processes underpinning this from a trades union perspective.

The booklet was billed as having startling new revelations about Dudley Council and how a political 'coup' in 1985 permitted the Conservative Party to resume power despite an electoral defeat in the 1984 local elections

# Maire O'Shea: The Case against the Prevention of Terrorism Act

This booklet was written by Marc Metcalf [of TURC] and published by the Maire O'Shea Support Committee with support from the Troops Out Movement and the Labour Committee on Ireland.

The publication used the case of Doctor O'Shea [an Irish woman practicing medicine in Sparkbrook] to highlight perceived difficulties with the application of the Prevention of Terrorism Act.

# MS 2009/D. TURC Print Ltd. n.d..

A Print function was established by TURC in 1983 to provide printing services to trades union branches and community groups. During 1984, a great deal of work was undertaken for Miners' Support Groups in the Midlands. In 1986 it became a separate subsidiary of the Centre.

In 1988 major refurbishment of the premises caused extensive water damage to electrical fittings and water stock, as well as general disturbance. This resulted in severe interruptions to production, and resulted in TURC instigating legal proceedings against their landlords. In 1989 TURC Print relocated to the ground floor. Further interruptions to productivity occurred during the planning and execution of this move.

TURC Print closed in 1992 when BCC reduced funding to cover only TURC's [original] core services of research and information.

#### MS 2009/E. TURC Video Ltd. 1984 - 1993.

A video function was established by TURC in 1984, as a consequence of its view that access to the Media represented a means of empowerment. In 1986 it became a separate subsidiary of the Centre. It was set up to undertake a wide range of video-related activities including production, operating a video library, promoting screenings of tapes, tape distribution and information and advice giving. It was committed to the opening up of the visual communication network to the whole community. TURC Video also provided video resources for community-based and independent producers in the West Midlands.

TURC's worsening financial situation led to Birmingham City Council requiring a reorganisation, and TURC Video merged with Wide Angle on 31st August 1992, their assets and business being transferred to the Birmingham Centre for Media Arts. This was jointly funded by Birmingham City Council and West Midlands Arts.
